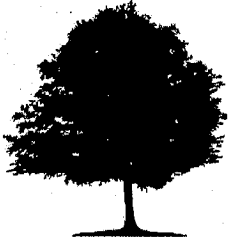

\_\_\_\_\_ I understand that an obituary is completed with information I provide and approve to Beddingfield Funeral Service. Beddingfield Funeral Service is not responsible for any omissions or errors in the obituary.

\_\_\_\_\_ I understand that unembalmed remains held longer than 24 hours must be refrigerated or embalmed by law (California Administrative Code, Section 1223C).

\_\_\_\_\_ There is no scientific or other evidence that any casket with a sealing device will preserve human remains. We do not guarantee any casket manufacturer's warranties.

\_\_\_\_\_ I understand that a cemetery is a separate entity from Beddingfield Funeral Service. I agree to hold Beddingfield Funeral Service harmless from any liability resulting from negligence or any other acts that may be committed by a cemetery or crematory.

\_\_\_\_\_ I understand that I may witness the actual cremation and/or personally identify the unembalmed remains before burial or cremation (additional charges may apply).

\_\_\_\_\_ I understand that Beddingfield Funeral Services will hold cremated remains for 10 days. After 10 days there is a storage fee of \$10 per day.

\_\_\_\_\_ I understand that if I select an arrangement with viewing, that I may have to pay for embalming.

\_\_\_\_\_ I understand that Beddingfield Funeral Service's payment policy requires full payment prior to services being rendered. I agree to pay Beddingfield Funeral Service all reasonable attorney's fees and costs that may incur in connection with any efforts taken to collect such payment.

\_\_\_\_\_ I understand that the death certificate is completed with the information I provide and approve to Beddingfield Funeral Service. Beddingfield Funeral Service will not be held liable for any mistakes in the information I provides. I understand that I will be responsible for any amendment to the death certificate.

\_\_\_\_\_ I understand that Beddingfield Funeral Service requires an escort if there is to be a procession from the church to the cemetery. Beddingfield Funeral Service does not allow anyone to follow the hearse without an escort.
